Program Costs

Horizon PACE accepts Medicare, Medicaid, or private payment. Our enrollment team will assist in determining if you will have a monthly premium and explain payment options.

Once enrolled, our team handles all paperwork and claims.

Enrollment & Eligibility

Enrolling into the Horizon PACE program is voluntary. Enrollment into PACE happens on the first day of the month after you are approved.

Individuals qualify if they are:

- 55 years or older;
- Living in the designated 14 county service area, including **Barren, Butler, Clinton, Estill, Jackson, Laurel, Logan, Madison, McCreary, Pulaski, Rockcastle, Simpson, Warren, and Wayne;**
- Certified to meet the nursing home level of care as defined by the state of Kentucky;
- Able to live safely in the community with the support of PACE at the time of enrollment.

Our PACE program covers a fourteen county service area with **PACE Centers in Bowling Green, Monticello, Richmond, and Somerset.**



Enrollment

An enrollment team member will meet with you, your family or caregiver to explain the program. You can disenroll in the PACE program at any time.

Provisions

The PACE team is made up of doctors, nurses, social workers, health aides, transportation staff, physical therapists, dietitians and others.

A personalized care plan is created for every participant. Prevention and wellness are always key factors. All services must be provided by Horizon PACE network providers. A list of network providers is included in the enrollment packet and is available at any time upon request.

PACE participants may be financially liable for any non-emergency care or services not authorized by the PACE interdisciplinary team.



PACE Services include:

- Adult Day Health Care
- Transportation to and from PACE Services
- Primary Health Care
- Specialty Care and Nursing Home Care, if needed
- Nursing Care and Personal Care
- Home Care
- Drug Coverage
- Health Care Supplies and Devices
- Meals
- Therapy Services (PT/OT)
- Respite Care
- Dental, Eye, and Foot Care
- Mental Health Care
- Social Services
- End-of-life Care
- Hospital Services
- Labs, X-rays and other testing
- 24 Hour on-call services

Each participant's services will be determined by their individual care plan.
